**RESOLUTION REQUESTING P/MAJOR GENERAL ANTONIO N. GARDIOLA, JR. (RET.), REGIONAL DIRECTOR, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB), REGIONAL OFFICE V TO CONDUCT INFORMATION, EDUCATION CAMPAIGN IN RELATION TO THE PROPOSED OPENING OF TRANSPORT NETWORK VEHICLE SERVICE (TNVS) TO INCLUDE GRAB TRIKE IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.**

**WHEREAS**, on March 18, 2022, Atty. Paul Vincent V. Austria, Acting, Chief Transportation Development Officer, LTFRB RV wrote a letter addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City respectfully requesting for a meeting in relation to the proposed opening of Transport Network Vehicle Service in the territorial jurisdiction of the City of Sorsogon;

**WHEREAS**, the same was among the items deliberated upon by the 7<sup>th</sup> City Council during the April 05, 2022 and was officially referred to the Committee on transportation and Public Utilities;

**WHEREAS**, on April 12, 2022, the Committee on transportation and Public Utilities called for a committee hearing inviting the presence of representatives from LTFRB Regional Office V, tricycle and jeepney association officers;

**WHEREAS**, through the Chairman of the Committee on Transportation and Public Utilities, it was therein discussed that an Information, Education Campaign be thoroughly conducted by LTFRB Regional Office V especially when attendees thereof expressed their apprehensions regarding the Proposed Opening of Transport Network Vehicle Service (TNVS) to include Grab Trike in the territorial jurisdiction of the City of Sorsogon;

Abenion** resolve as it is hereby resolved to request P/Major General Antonio N.
