RESOLUTION AUTHORIZING THE CHANGE OF THE DESIGNATED TRUST FUND ACCOUNT NO. 0645-011564-085 OF THE CITY GOVERNMENT OF SORSOGON WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) TO ACCOUNT NO. 0645-011564-084 AS THE REGULAR TRUST FUND ACCOUNT OF THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the April 29, 2022 Regular Session of the 7<sup>th</sup> City Council is the Transmittal No. 24, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary dated April 20, 2022, respectfully requesting for the passage of a resolution authorizing the change of the designated Trust Fund Account No. 0645-011564-085 of the City Government of Sorsogon with the Development Bank of the Philippines (DBP) to Account No. 0645-011564-084 as the regular Trust Fund Account of the City of Sorsogon;

**WHEREAS**, said request authorizes the change of the designated purpose of the Trust Fund Account No. 0645-011564-085 of the City Government of Sorsogon with the Development Bank of the Philippines (DBP) from "Bottoms-Up-Budgeting (BuB)" to "National Government Agency Funds";

**WHEREAS**, said account shall be used as the depository account for downloaded funds from the National Government until such time that these shall be used for its designated purpose;

**WHEREAS,** a Resolution authorizing the designation of Account No. 0645-011564-084 with Development Bank of the Philippines (DBP) as the regular Trust Fund Account of the City Government of Sorsogon is likewise requested;

**NOW THEREFORE,** on motion of **Hon. Joven Francis J. Laura,** duly seconded by **Hon. Mary Ellen D. Jamisola,** resolve as it is hereby resolved to authorize the change of the designated Trust Fund Account No. 0645-011564-085 of the City Government of Sorsogon with the Development Bank of the Philippines (DBP) to Account No. 0645-011564-084 as the regular Trust Fund Account of the City of Sorsogon;
