RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH TOTAL TRANSCRIPTION SOLUTIONS, INC. (TTSI) REPRESENTED BY MARGARITA M. PAZ, CHIEF OPERATING OFFICER RELATIVE TO THE PROVISIONS OF PHILHEALTH- ACCREDITED ELECTRONIC CLAIMS MODULES

WHEREAS, among the items deliberated during the April 29, 2022 Regular Session of the 7th City Council is the Committee Report No. 27, Series of 2022 of the Committee on health and Sanitation relative to the letter request from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Total Transcription Solutions, Inc. (TTSI) represented by Margarita M. Paz, Chief Operating Officer relative to the provisions of Philhealth-Accredited electronic claims modules;

WHEREAS, TTSI is a Philhealth-accredited Health Information Technology Provider (HITP) for Philhealth's electronic claims (e-claims) system;

WHEREAS, incorporated under the provisions of the Memorandum of Agreement (MOA) are the responsibilities of both parties;

WHEREAS, the said Memorandum of Agreement (MOA) shall pave the way for the establishment of a Philhealth EClaims System which shall be beneficial to the people of Sorsogon;

WHEREAS, to finally begin the local implementation of such, a resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement with the TTSI is requested;
