RESOLUTION MOST RESPECTFULLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) 1<sup>ST</sup> ENGINEERING DISTRICT TO ALLOCATE FUNDS INTENDED FOR THE ESTABLISHMENTS AND INSTALLLATION OF TRAFFIC LIGHTS IN ALL STRATEGIC INTERSECTION AND JUNCTION ROADS IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON

**WHEREAS**, every year, an estimated 1.2 million dies and over 50 million are injured in road accidents across the world, with around 85% of these numbers coming from low-and-middle income countries;

**WHEREAS**, in 2011, the Philippines, through the Department of Transportation (DOTr) developed the Philippine Road Safety Action Plan (PRSAP) 2011 to 2020 with the goal of reducing the number of road accidents in the Philippines by 50% by 2020;

WHEREAS, in order to reduce the number of road accidents and decongest heavy traffic in the City of Sorsogon and or minimize their severity, there is a need to install sufficient warnings on roads by installing appropriate road and traffic signages and traffic lights in all strategic intersection and junction roads in the territorial jurisdiction of the City of Sorsogon;

**WHEREAS**, traffic lights play a vital role and crucial role in the flow of traffic everyday for it prevents or at least reduces the cases of car crash and collisions in the roads especially in intersections and it provides a safe and orderly flow of cars on the roads and highways;

**WHEREAS,** it is therefore requested to prioritize the establishment and installation of traffic lights along Bibincahan- Cabid-an- Diversion Road, at Pangpang Junction Road and Abuyog-Casiguran Junction Road;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE,** on motion of **Hon. Joven Francis J. Laura,** duly seconded by **Hon. Mary Ellen D. Jamisola** resolve as it is hereby resolved to most respectfully request the Department Of Public Works And Highways (DPWH) 1<sup>st</sup> Engineering District to Allocate Funds intended for the Establishments and Installation of Traffic Lights in all Strategic Intersection and Junction Roads in the Territorial Jurisdiction of the City of Sorsogon;
