RESOLUTION ISSUING TRICYCLE FRANCHISE TO FIVE (5) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 174 & 177, SERIES OF 2022 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”

WHEREAS, SP Resolution No.174 and 177, Series of 2022, approved on April 19, 2022 officially cancelled and revoked tricycle franchises in favor of the City Government of Sorsogon, in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”;

WHEREAS, on April 22, 2022, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the two (2) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. Tricycle Franchise No. 2880/Tricycle Franchise Plate No. 2880 awarded in the name of **NILDA S. PALENCIA** of Pangpang, West D. Sorsogon City, with the route covered by GUINPABTODA
2. Tricycle Franchise No. 3446/Tricycle Franchise Plate No.3446 awarded in the name of **ISAGANI DOLLENTE** of Bibincahan, East D. Sorsogon City, with the route covered by PTOA
3. Tricycle Franchise No. 2397/Tricycle Franchise Plate No.2397 awarded in the name of **LORETO P. CAUBANG** of Barayong, West D. Sorsogon City, with the route covered by SOTRIDA
4. Tricycle Franchise No. 0131/Tricycle Franchise Plate No.0131 awarded in the name of **GIRLIE G. DOLOSA** of Sampaloc, East D. Sorsogon City, with the route covered by GUINPABTODA
5. Tricycle Franchise No. 2518/Tricycle Franchise Plate No.2518 awarded in the name of **ORLANDO MACAPAGAL** of Bibincahan, East D. Sorsogon City, with the route covered by MATRIODAS

WHEREAS, Section 14 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on motion of **Hon. Joven Francis J. Laura** duly seconded by **Hon. Mary Ellen D. Jamisola**, resolved as it is hereby resolve to issue tricycle franchise to five (5) qualified waiting applicant from previously cancelled/revoked tricycle franchises under SP Resolution No. 174 & 177, Series of 2021 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.
