RESOLUTION ENDORSING THE CONSTRUCTION OF SORSOGON POLICE PROVINCIAL OFFICE (PPO) COVERED FIRING RANGE AND BASKETBALL COURT AT CAMP SALVADOR C. ESCUDERO SR., SORSOGON CITY FOR INCLUSION TO THE REGIONAL DEVELOPMENT INVESTMENT PROGRAM (RDIP) OF THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA).

WHEREAS, among the items deliberated during the October 05, 2021 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E.
