RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, AS THE CHAIRMAN OF THE SORSOGON CITY ADVISORY COUNCIL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SORSOGON CITY PHILIPPINE NATIONAL POLICE (PNP) REPRESENTED BY POLICE MAJOR JERIC DON P. SADIA, OFFICER-IN-CHARGE, RELATIVE TO THE IMPLEMENTATION OF PROJECT 3K (KOMUNIKASYON KONTRA KRIMINALIDAD).

WHEREAS, among the items deliberated during the October 12, 2021 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated October 11, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her as the Chairman of the Sorsogon City Advisory Council to enter into a Memorandum of Agreement (MOA) with the Sorsogon City Philippine National Police (PNP) represented by Police Major Jeric Don P. Sadia, Officer-in-Charge relative to the implementation of Project 3K (Komunikasyon Kontra Kriminalidad);

WHEREAS, Project 3K aims to provide a convenient way of communicating between barangays and various sectors in forwarding reports and facilitating the necessary actions to address concerns raised by the community;

WHEREAS, the realization of the said project shall be facilitated with the perfection of a Memorandum of Agreement (MOA) by and between the Sorsogon City Police Station and the City Advisory Council wherein the roles and responsibilities of the parties are stipulated;

WHEREAS, the Sorsogon City Police Station is mandated to maintain peace and order, prevent and control crimes and take all these steps to ensure public safety;

WHEREAS, the City Government of Sorsogon plays a major role in a community's development, provide the links between the people and the government address its community's problems and concerns, enforce policies and hold influence over its barangays;

WHEREAS, the City Advisory Council primary function is to assist in identifying key issues and provide strategic advice consistent with the PNP's policies, plans and programs cognizant of the political, social, economic, cultural and moral development needs of the community and the PNP:

WHEREAS, the barangay as the smallest unit of the government has the direct involvement in addressing issues of its constituents arising in their respective community;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement for further perusal of the 7th City Council;

NOW THEREFORE, on incidental motion of Hon. Franco Eric O. Ravanilla, duly seconded by Hon. Ma. Teresa D. Perdigon resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into as the Chairman of the Sorsogon City Advisory Council to enter into a Memorandum of Agreement (MOA) with the Sorsogon City Philippine National Police (PNP) represented by Police Major Jeric Don P. Sadia, Officer-in-Charge relative to the implementation of Project 3K (Komunikasyon Kontra Kriminalidad);
