RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO AN INTER-AGENCY MEMORANDUM OF AGREEMENT (MOA) NAMELY: BICOL UNIVERSITY (BU), LEGAZPI CITY, ALBAY, SORSOGON STATE UNIVERSITY (SSU), SORSOGON CITY AND SORSOGON PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (SPDRMO), SORSOGON CITY RELATIVE TO THE IMPLEMENTATION OF THE SCIENCE AND TECHNOLOGY BASED REHABILITATION OF DAMAGES CAUSED BY SUPER TYPHOON ROLLY IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the October 12, 2021 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated October 11, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into an Inter-Agency Memorandum of Agreement (MOA) namely: Bicol University (BU), Legazpi City, Albay, represented by Dr. Arnulfo M. Macarinas, SUC IV University President, Sorsogon State University

(SSU), Sorsogon City, represented by Dr. Helen R. Lara, President and Sorsogon Provincial Disaster Risk Reduction Management Office (SPDRRMO), Sorsogon City, represented by Atty. Enrique J. Renoria, Provincial Administrator, relative to the implementation of the Science & Technology based rehabilitation of damages caused by Super Typhoon Rolly in the City of Sorsogon;

WHEREAS, the project entails to capacitate communities through the conduct of technical trainings and stress debriefing and facilitating the distribution of product packages for qualified individuals and this comprehensive collaboration among the above listed parties is expected to provide social and economic impacts to affected communities thereby lifting their spirits and strengthening their resiliency;

WHEREAS, one of the cities greatly affected is the City of Sorsogon where heavy downpour of rains and strong winds affected most of the agricultural lands and houses;

WHEREAS, with the City of Sorsogon as one of the significant hotspots of disasters and economic development, application of Science and Technology (S & T) in disaster risk reduction (DRR) is an essential requirement for disaster governance;

WHEREAS, Bicol University through Bicol University College of Agriculture and Forestry (BUCAF), Sorsogon State University (SSU) and LGU – Sorsogon City, SPDRRMO recognizes that post-disaster recovery activities such as rehabilitation of areas affected by natural disasters using S & T based interventions enhance resiliency and adaptive capacities of families/households and natural ecosystems;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Ma. Teresa D. Perdigon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E.
