**RESOLUTION REQUESTING THE LOCAL INTER-AGENCY TASK FORCE FOR
THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-
SORSOGON CITY) TO ALLOW AND AUTHORIZE THE ACCOMMODATION
OF THREE (3) PASSENGERS IN TRICYCLES-FOR-HIRE IN THE CITY OF
SORSOGON WITH ITS GOVERNING GUIDELINES THEY MAY THEREIN
PROVIDE FOR THE PURPOSE**

WHEREAS, due to policies and protocols imposed by the national government,
through its national IATF in observance with quarantine status during pandemic, the
Sangguniang Panlungsod had passed and approved an ordinance for the temporary or
provisional fare matric for tricycles-for-hire in the city of Sorsogon which is an additional
economic burden of the general public;

WHEREAS, the tricycle transport sector of the city of Sorsogon, by way of
Sangguniang Panlungsod resolution, had been previously allowed by the local IATF to

accommodate two (2) passengers with its governing guidelines as therein defined for the purpose;

WHEREAS, the drastic price increases in gasoline persuaded the sector to likewise request for a fare hike to at least maintain the economic equilibrium;

WHEREAS, majority of the laborers and workers in the City of Sorsogon and the general riding public are reliant to tricycles-for-hire as their primary mode of transportation in going to and from their respective work places and part of community daily routine;

WHEREAS, to maintain the local economic equilibrium between the tricycle transport sector and of the general riding public in the City of Sorsogon and in order not to issue another emergency or special fare matrix, it is most respectfully requested to allow the accommodation of three (3) passengers in tricycles-for-hire operating in the city jurisdiction;

WHEREAS, tricycles-for-hire will be allowed only to accomodate three (3) passengers upon compliance with the suggested/proposed guidelines, to wit:

1. The tricycle shall have a durable protective shield or plastic partition placed in between the driver and the back-ride in the motorcycle unit.
2. The tricycle shall have a durable protective shield or plastic partition placed in between the motorcycle unit and of the sidecar.
3. Sidecar seat shall be divided with a roll up durable protective shield or plastic partition placed in between the two passengers.
4. No face mask and no face shield- no ride policy shall be strictly enforced.
5. Alcohol and/or sanitizer shall always be available at all times.

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to request the Local Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases (IATF-Sorsogon City) to allow and authorize the accommodation of three (3) passengers in Tricycles-for-hire in the City of Sorsogon with its governing guidelines they may therein provide for the purpose.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
