WHEREAS, on October 19, 2021, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption, approval and enactment of RESOLUTION NO. 09, SERIES OF 2021 OF THE CITY DEVELOPMENT COUNCIL (CDC) held last October 15, 2021 entitled "RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF FOURTEEN MILLION (P14,000,000.00) PESOS FROM ITEM NO. II-3 AND IV-2 (CONSTRUCTION/IMPROVEMENT OF IRRIGATION SYSTEM AND ESTABLISHMENT OF ECO PARK) TO ITEM NO. III-5 (REHABILITATION/IMPROVEMENT OF MARKET STALLS @ SORSOGON CITY PUBLIC MARKET), ITEM NO. III-6 (CONSTRUCTION OF MARKET STALLS, ROOF COVER AND STORAGE @ SORSOGON CITY PUBLIC MARKET) ITEM NO.IV-3 (PURCHASE OF MINI DUMP TRUCK), ITEM NO. WHEREAS, the identified programs, projects and activities were meant to sustain responsiveness of government service by providing the best economic and environmental services beneficial to the people;

WHEREAS, after thorough deliberation of the projects funded and to be implemented under the 2021 20% Development Fund, the construction /improvement of irrigation system and establishment of eco park can no longer be implemented this year due to two (2) on-going irrigation projects funded under the 2021 20% Development Fund and 2021 General Fund and such eco park is expected to finish in the later part of 2022 thus additional funding for current year is not necessary;

WHEREAS, the projects identified are urgently needed in order to give the best economic and environmental service to the people of Sorsogon and these are unanticipated yet essential PPA's;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O.
