RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY RELATIVE TO THE CONSTRUCTION OF HOG MULTIPLIER AT SITIO MADAN-AN, SAN JUAN, EAST DISTRICT, SORSOGON CITY, AS AN ESSENTIAL PART OF THE PROCUREMENT PROCESS.

WHEREAS, among the items deliberated during the October 26, 2021 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated October 25, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution ratifying the Contract entered into by Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City relative to the construction of hog multiplier at Sitio Madan-an, San Juan, East District, Sorsogon City, as an essential part of the procurement process;

WHEREAS, said project is under the previously perfected Memorandum of Agreement (MOA) among the Department of Agriculture (DA), the Agricultural Training

Sorsogon relative to the Swine Multiplier and Technodemo Farm Project under the “Nucleus and Mutiplier Breeder Farms for Poultry, Swine and Small Ruminants Project;

WHEREAS, the Entity is desirous that the Contractor execute Construction of Hog Multiplier at Sitio Madan-an, Barangay San Juan (Roro), East District, Sorsogon City under Contract Reference No. CW 2021-07-020 (hereinafter called “the Works”) and the Entity has accepted the Bid for Two Million Nine Hundred Thirty Three Thousand Eighty Eight & 69/100 Pesos (P 2,933,088.69) only by the Contractor for the execution ad completion of such Works and the remedying of any defects therein;


