**RESOLUTION ISSUING TRICYCLE FRANCHISE TO SEVEN (7) QUALIFIED
WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE
FRANCHISES UNDER SP RESOLUTION NO. 311, SERIES OF 2021 IN ACCORDANCE
WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE
“SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”**

WHEREAS, SP Resolution No. 311, Series of 2021, approved on October 19, 2021
officially cancelled and revoked in favor of the City Government of Sorsogon Tricycle
Franchise Nos. 3976, 4632, 1028, 2087, 0599, 0790 and 0930, in accordance with City
Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle
Franchise Code of 2020”;

WHEREAS, on October 22, 2021, the Tricycle Franchising Regulatory Office through
the SP Committee on Tricycle Franchise endorsed the seven (7) qualified waiting
applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **MIKKO P. LELIS** of Barangay Balogo, East District, Sorsogon City for Tricycle Franchise No. 3976/PTODA.
2. **BERNADETTE D. BIO** of Barangay Macabog, West District, Sorsogon City for Tricycle Franchise No. 4632/MATRIODAS.
3. **ROMEO DOLOIRAS** of Barangay Balogo, East District, Sorsogon City for Tricycle Franchise No. 3976/SOTRIDA.
4. **VINCENT J. LAGUNILLA** of Barangay Pangpang, West District, Sorsogon City for Tricycle Franchise No. 2087/CAMTUTODA.
5. **RAMON H. DEOCAREZA** of Barangay Poblacion, Bacon District, Sorsogon City for Tricycle Franchise No. 0599/PTODA.
6. **LEO D. GONZAGA** of Barangay Bucalbucalan, West District, Sorsogon City for Tricycle Franchise No. 0790/PTODA.
7. **RELEO JAY D. TEODORO** of Barangay Bibincahan, East District, Sorsogon City for Tricycle Franchise No. 0930/PTODA.

WHEREAS, Section 14 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by Hon. Fernando David H. Duran, III, resolved as it is hereby resolve issue tricycle franchise to seven (7) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP resolution No. 311, Series of 2021 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.
