**RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF

**WHEREAS**, on September 02, 2021, Ms. Monich D. De los Angeles wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor expressing her intent to venture, engage and establish a Technology Solution Retail Outlet (Mini Portable Gasoline Station at Barangay Osiao, Bacon District, Sorsogon City;

**WHEREAS**, the matter was among the items deliberated upon by the 7<sup>th</sup> City Council and was officially referred to the Committee on Public Order and Safety;

**WHEREAS**, on October 08, 2021, a Committee Hearing was conducted for the purpose and subsequent Committee Report was included in the Agenda during the October 12, 2021 Regular Session;
