**RESOLUTION MOST RESPECTFULLY REQUESTING THE SORSOGON CITY
INTER-AGENCY TASK FORCE (IATF) ON COVID-19 TO ALLOW THE USAGE
OF ROMPEOLAS PARK AND OTHER PARKS IN THE CITY OF SORSOGON
FOR PHYSICAL FITNESS ACTIVITIES AS REQUESTED BY HEALTH AND
WELLNESS ADVOCATES IN THE CITY OF SORSOGON SUBJECT TO
COMPLIANCE WITH THE REQUIRED MINIMUM HEALTH PROTOCOLS.**

WHEREAS, the City of Sorsogon is already classified by the Inter-Agency Task Force (IATF) under Low-risk category with only more than 100 active cases of infected COVID-19 and has already allowed several restricted policies such as curfew adjustments, lifting of liquor ban and opening of several business establishments for economic development of the City;

WHEREAS, the overarching need to reduce disease transmission of COVID-19 has had an enormous impact on sports and exercise which have led to reduced physical activity and increased sedentary behavior to the constituents in the City of Sorsogon;

WHEREAS, the Department of Health is advocating that in order for us to combat COVID-19, everybody is encourage to boost their immune system by taking vitamins, conduct physical exercises, and having vaccinated;

WHEREAS, several wellness and physical fitness aficionados in the City have requested to allow them to use Rompeolas parks and other parks in the City of Sorsogon intended for their physical exercises such as jogging, walking, and other form of exercises;

WHEREAS, it is therefore just and proper to allow the health and wellness aficionados in the City to conduct physical activities in the aforesaid areas considering almost 100 % of them have already been vaccinated;

WHEREAS, while we allow business establishments with face-to-face interactions such as dine-in bar and restaurants with a required 50 percent capacity, the Sorsogon City Inter-Agency Task Force should also allow physical fitness activities in the City of Sorsogon open spaces;

NOW THEREFORE, on motion of Hon. Erwin J. Duana duly seconded by Hon. Nestor J. Baldon resolve as it is hereby resolved to most respectfully request the Sorsogon City Inter-Agency Task Force (IATF) on Covid-19 to allow the usage of Rompeolas Park and Other Parks in the City of Sorsogon for Physical Fitness Activities as requested by Health and wellness advocates in the City of Sorsogon subject to compliance with the required minimum health protocols.
