RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PURCHASE EIGHT (8) PARCELS OF LAND WITH AGGREGATE AREA OF ONE THOUSAND THREE HUNDRED SEVENTY NINE SQUARE METERS (1, 379 sq. m.) SITUATED AT SITIO BARIBAG, BRGY. BIBINCAHAN, EAST DISTRICT, SORSOGON CITY AMOUNTING TO ONE MILLION FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P 1,575,000.00) INTENDED FOR THE CONSTRUCTION OF AN ACCESS ROAD GOING TO THE SOON TO BE ESTABLISHED JUVENILE FACILITY

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter/Transmittal No. 59-2021, dated October 25, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda and to the honorable members of the 7<sup>th</sup> City Council, requested to pass a resolution authorizing her to purchase eight (8) parcels of land situated at Sitio Baribag, Brgy. Bibincahan, East District, Sorsogon City intended for the construction of an access road going to the soon to be established Juvenile Facility;

**WHEREAS**, the Office of the City Mayor was already in receipt of a the Valuation Report and has begun the preparation of documents for the expeditious processing of the purchase of the said property from its registered owner, Ms. Belinda B. Aguirre;

**WHEREAS,** the sale shall cover eight (8) parcels of land containing area of One Thousand Three Hundred Seventy Nine Square Meters (1, 379 sq. m.) located in front of the Sorsogon State University Campus Extension – Engineering Department at Sitio Baribag, Brgy. Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to purchase eight (8) parcels of land with aggregate area of One Thousand Three Hundred Seventy Nine Square Meters (1, 379 sq. m.) situated at Sitio Baribag, Brgy. Bibincahan, East District, Sorsogon City amounting to One Million Five Hundred Seventy Five Thousand Pesos (Php 1,575,000.00) intended for the construction of an access road going to the soon to be established Juvenile Facility.
