RESOLUTION MOST RESPECTFULLY REQUESTING HON. GOVERNOR FRANCIS JOSEPH "CHIZ" ESCUDERO AND 1ST DISTRICT CONGRESSWOMAN HON. EVELINA G. ESCUDERO TO ALLOCATE FUNDS INTENDED FOR THE CONSTRUCTION OF DOCK YARDS AND TRADING POSTS FOR THE BARANGAYS OF SAMPALOC, BITAN-O AND CAMBULAGA, ALL OF SORSOGON CITY AND FOR THE INSTALLATION OF TERRITORIAL DEMARCATION BUOYS IN THE SORSOGON BAY

WHEREAS, fishermen from the Barangays of Sampaloc, Bitan-o and Cambulaga were affected by the construction of the coastal road depriving them of shoreline/seaside space for parking their bancas and fishing paraphernalia;

WHEREAS, trading posts located along the shoreline of the said barangays were likewise affected by the said project;

WHEREAS, providing them with necessary space and reliable docking yard/facility and concrete trading posts would bring convenience and economic advantage to the sector:

WHEREAS, Republic Act No. 8550, otherwise known as "The Philippine Fisheries Code of 1998", Section to thereto explicitly mandates that the municipality/city government shall have jurisdiction over municipal waters and in consultation with the Fisheries and Aquatic Resources Management Councils (FARMC) shall be responsible for the management, conservation, development, protection, utilization and disposition of all fish and fishery/aquatic resources within their respective jurisdiction;

WHEREAS, demarcation buoys to delineate maritime territorial jurisdiction of the city and neighboring municipalities occupying the Sorsogon Bay is also of great necessity to avoid confusion and misunderstanding in the enforcement of their respective fishery code and other related local policies in the management, protection and conservation of marine resources;

NOW THEREFORE, on motion of Hon. Joven Francis J. Laura duly seconded by Hon. Fernando David H. Duran, III, resolved as it is hereby resolve to respectfully request Hon. Governor Francis Joseph "Chiz" Escudero and 1st District Congresswoman Hon. Evelina Escudero to allocate funds intended for the construction of dock yards and trading posts for the barangays of Sampaloc, Bitan-o and Cambulaga, all of Sorsogon City and for the installation of territorial demarcation buoys in the Sorsogon Bay.
