**RESOLUTION SUSPENDING THE IMPLEMENTATION OF SECTION 107 OF
CITY ORDINANCE NO. 16, SERIES OF 2014 OTHERWISE KNOWN AS THE
SORSOGON CITY TRANSPORTATION AND TRAFFIC CODE OF 2014.**

WHEREAS, cursory reading of Section 107 of City Ordinance No. 16, series of 2014 states that any amount imposed upon the offender shall be remitted by the apprehending officer, traffic enforcer, members of the PNP and any member of the Traffic Management Section designated for the purpose to the City Treasurer who shall set aside 30% thereof which shall be given to the officer on monthly basis;

WHEREAS, having apprehensions on said provision, a solicited advice was made before Atty. Cyril Oropesa, City Legal Officer during a committee hearing wherein the latter opined that such maybe be legally disputed;

WHEREAS, research conducted in relation to this issue also reveals that the Metro Manila Development Authority previously granted and allocated portion of the Traffic

Citation Tickets for apprehending officers, however, the same was disallowed by the Commission on Audit (COA);

WHEREAS, in addition thereto, such provision of local ordinance would encourage indiscriminate apprehensions and issuance of traffic citation tickets by apprehending officers bearing in mind that they shall be receiving 30% of the penalty imposed upon traffic offenders;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution suspending the implementation of Section 107 of City Ordinance No. 16, series of 2014 otherwise known as the Sorsogon City Transportation and Traffic Code of 2014;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to suspend the implementation of Section 107 of City Ordinance No. 16, series of 2014 otherwise known as the Sorsogon City Transportation and Traffic Code of 2014;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
