**RESOLUTION RESPECTFULLY REQUESTING ATTY. CYRIL C. OROPESA,
CITY LEGAL OFFICER FOR CITY LEGAL OPINION ON THE MATTER OF THE
MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY LKY AND THE
CITY GOVERNMENT OF SORSOGON**

WHEREAS, during the incumbency of the late Mayor Leovic R. Dioneda, a
Memorandum of Agreement was consummated by and between the former representing
the LGU and LKY CORPORATION represented by Mr. Wilbert Lee;

WHEREAS, the aforesaid MOA involves two subject matters which are the Grand
Terminal located at Barangay Balogo, Sorsogon City and the terminal situated at
Barangay Sulucan at the basement of Savemore;

WHEREAS, some members of the City Council who are not privy to the
negotiations until the final forging of the MOA relative to the Grand Terminal sometime

in 2007, believed that the twenty five year term efficacy thereof be respected and faithfully complied by the parties ;

WHEREAS, it has been observed as it is highly noticeable that the Grand Terminal has been demolished in violation of MOA which is supposedly be turned over to the City Government considering that it is under BOT scheme;

WHEREAS, it is appropriate at this point in time to ascertain whether the demolition of the Grand Terminal caused prejudice to the interest of the City Government or otherwise stated beneficial to the LGU and henceforth this request.

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to respectfully request Atty. Cyril C. Oropesa, City Legal Officer for City Legal Opinion on the matter of the Memorandum of Agreement (MOA) entered into by LKY and the City Government of Sorsogon.
