RESOLUTION RESPECTFULLY APPEALING PETRON CORPORATION THROUGH MS. MIA S. DELOS REYES, OFFICER-IN-CHARGE, CORPORATE AFFAIRS TO CONSIDER EXTENDING GASOLINE DISCOUNTS TO FULLY VACCINATED AND PARTIALLY VACCINATED INDIVIDUALS EVEN WITHOUT PRESENTING PETRON VALUE CARD AND/OR SUPER DRIVER CARD UNTIL DECEMBER 31, 2021.

WHEREAS, on September 21, 2021 regular session of the 7th City Council, Resolution No. 271, series of 2021 was approved entitled “**RESOLUTION RESPECTFULLY REQUESTING SHELL PHILIPPINES, PETRON AND CALTEX (BIG THREE PLAYERS) TO EXTEND GASOLINE DISCOUNTS OFFERED TO FULLY VACCINATED AND/OR THOSE WHO HAVE JUST RECEIVED FIRST DOSE GASOLINE CONSUMERS UNTIL DECEMBER 31, 2021;**

WHEREAS, the intent of the aforementioned resolution is to encourage our fellow citizens to be vaccinated and attain a herd immunity;

WHEREAS, aside from encouragement, Panalo Bakuna Promo of Petron would greatly contribute in helping our gasoline consumers ease the financial burden on unpredictable gasoline escalation;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution appealing Petron Corporation through Ms. Mia S. Delos Reyes, Officer-In-Charge, Corporate Affairs to consider extending gasoline discounts to fully vaccinated and partially vaccinated individuals even without presenting Petron Value Card and/or Super Driver Card until December 31, 2021;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Lorenz S. Abenion**, resolve as it is hereby resolved to appeal Petron Corporation through Ms. Mia S.
