**RESOLUTION AUTHORIZING THE GRANT OF GASOLINE SUBSIDY OF TWO
(2) LITERS PER MONTH PER QUALIFIED TRICYCLE FRANCHISE HOLDERS
COMMENCING OCTOBER 2021 TO DECEMBER 2021.**

WHEREAS, on October 18, 2021 the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City endorsed to the Sangguniang Panlungsod the concerns of Mr. Edwin Altavano and Mr. Albert Frayna, Tricycle Association Presidents Of PVTODA and SUBTRODAs respectfully requesting for Fare Hike in the amount of One to Two Pesos per passenger;

WHEREAS, the matter was officially referred to the Committee on Transportation in order to tackle the matter with the presence of the requesting party;

WHEREAS, the 7th City Council approved and adopted Committee Report No. 089, series of 2021 submitted by the Committee on Transportation in relation to the requested Tricycle Fare Hike wherein the legislative department strongly supported the committee recommendation to Grant of Gasoline Subsidy to Tricycle Franchise Holders instead of

resulting to Tricycle Fare Hike which would mean an additional burden to commuters and the general public as well;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the grant of Gasoline Subsidy of Two (2) Liters per month per Qualified Tricycle Franchise Holders commencing October 2021 to December 2021;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Erwin J. Duana**, resolved as it is hereby resolve to authorize the grant of Gasoline Subsidy of Two (2) Liters per month per Qualified Tricycle Franchise Holders commencing October 2021 to December 2021;
