**RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY HON. CITY  
MAYOR MA. ESTER E. HAMOR WITH THE GRANTOR AND THE WINNING  
BIDDER RELATIVE TO THE REPAIR/REHABILITATION OF FLOOD CONTROL  
STRUCTURE PROJECT, WITH AN AMOUNT OF ₱ 10,163,161.00 UNDER THE  
TRUST FUND ACCOUNT OF THE CITY GOVERNMENT OF SORSOGON**

**WHEREAS**, the Hon. City Mayor Ma. Ester E. Hamor, on its letter/Transmittal No. 60, Series of 2021, dated October 26, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda and to the honorable members of the 7<sup>th</sup> City Council, requested to pass an individual resolution relative to the various projects under the Trust Fund Account of the city government of Sorsogon, among which is the Repair/Rehabilitation of Flood Control Structure Project, with an amount of ₱ 10,163,161.00;

**WHEREAS**, this measure aims to extend assistance and support to the herein project of the city government of Sorsogon for the expeditious procurement processes

and payment to suppliers and/or contractors;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to ratify the contract entered into by Hon. City Mayor Ma. Ester E. Hamor with the Grantor and the Winning Bidder relative to the Repair/Rehabilitation of Flood Control Structure Project, with an amount of ₱ 10,163,161.00 under the Trust Fund Account of the city government of Sorsogon.
