**RESOLUTION REQUESTING THE BICOL INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF - SORSOGON CITY) TO ALREADY ALLOW THE OPENING OF SPORTS FACILITIES AND SPORTS ACTIVITIES FOR VACCINATED PARTICIPANTS IN THE BARANGAYS WITH ZERO CASE OF COVID 19 AND ISSUE THE CORRESPONDING GUIDELINES FOR THE PURPOSE**

**WHEREAS**, the state recognizes the vital role of the youth in the nation-building, thus, the Constitution mandates the promotion of their physical, moral, spiritual, intellectual and social being;

**WHEREAS**, the state further mandates the formulation, adoption and implementation of an integrated and coordinated youth development program which is responsive to the needs and involvement of the youth in the affairs of the state;

**WHEREAS**, Article XIV, Section 19 (1) of the 1987 Constitution provides that “The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry”;

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF- Sorsogon City) is hereby requested to issue guidelines for the opening of sports facilities and allowing sports activities for those already vaccinated in the barangays, with the corresponding guidelines and restrictions they may impose for the purpose;

**WHEREAS**, the 7<sup>th</sup> City Council is further requesting for the inclusion of the suggestions:

1. There shall be a certification from the City Health Office that the barangay has no Covid 19 case and thereby allowed to open its sports facilities to their constituents.
2. Sports facilities in the barangays with no Covid case shall be opened from 5am to 5pm.
3. Use of sports facilities and sports activities in the barangays shall only be allowed to 18 to 60 years old and must be vaccinated.
4. Strict observance to the minimum health standards/protocols such as social distancing, washing of hands or application of alcohol before and after the game.
5. Regular conduct of disinfections to sports facilities and venue of activities.
6. No players shall be allowed to use any sports facilities in the barangay, unless a prior notice is given and approved by the Brgy. Kagawad, Chairman of the Committee on Youth and Sports Development and/or by the Punong Barangay for proper planning and scheduling.
7. Participants in the scheduled sports activities in the barangay shall be required submit themselves for temperature check and to deposit any valid ID which shall be returned after the game.
8. No sports tournament shall be allowed.
9. Strict prohibition on game fixing and betting.
10. When the barangay recorded a Covid case, sports facilities and sports activities shall be temporarily suspended until further notice and certification from the City Health Office that the barangay is again qualified to open its sports facilities.

**NOW THEREFORE**, on motion of **Hon. Mark Eric C. Dioneda**, duly seconded by **Hon. Ma. Teresa D. Perdigon**, resolve as it is hereby resolved to request the Bicol Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF -Sorsogon City) to already allow the opening of sports facilities and sports activities in the barangays with zero case of Covid 19 and issue the corresponding guidelines for the purpose.

**RESOLVED**, further, that copies of this resolution be furnished to all concerned for their information and guidance.
