RESOLUTION RESPECTFULLY REQUESTING THE SORSOGON CITY LOCAL INTER AGENCY TASK FORCE ON COVID 19 TO ALLOW FACE TO FACE CONDUCT OF COCKFIGHTING AT AUTHORIZED COCKPIT ARENA PROVIDED THAT ONLY FULLY VACCINATED INDIVIDUALS SHALL BE ACCOMMODATED AND MINIMUM HEALTH PROTOCOLS ARE STRICTLY IMPLEMENTED

WHEREAS, following increase in COVID 19 cases in our locality, cockpit operations were temporarily suspended in order to contain the exponential spread of COVID 19 cases;

WHEREAS, just recently, health authorities recorded considerable decrease in COVID 19 cases in our locality prompting local authorities to relax at a considerable level business operation in our locality;

WHEREAS, cockfighting aficionados are among those requesting that cockfighting in authorized cockfighting arena be allowed via Face-to-Face instead of engaging in "TUPADA" which is illegal;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Concil deemed it necessary to pass a resolution respectfully requesting the Sorsogon City Local Inter Agency Task Force on COVID 19 to allow Face to Face conduct of Cockfighting at authorized Cockpit Arena provided that only fully vaccinated individuals shall be accommodated and Minimum Health Protocols are strictly implemented;

NOW THEREFORE, on incidental motion of **City Councilor Nestor J. Baldon** duly seconded by **City Councilor Franco Eric O. Ravanilla**, resolve as it is hereby resolved to respectfully request the Sorsogon City Local Inter Agency Task Force on COVID 19 to allow Face to Face conduct of Cockfighting at authorized Cockpit Arena provided that only fully vaccinated individuals shall be accommodated and Minimum Health Protocols are strictly implemented;
