WHEREAS, among the items deliberated during the November 09, 2021 Regular Session of the 7th City Council is a Committee Report No. 093, Series of 2021 of the Committee on Livelihood, Cooperatives, POs, GOs and NGOs requesting for accreditation of Sawanga Fisherfolks Association by the Sangguniang Panlungsod;
