RESOLUTION REQUESTING ALL SANGGUNIANG KABATAAN (SK) OF THE 64 BARANGAYS IN THE CITY OF SORSOGON TO UTILIZE PORTION OF THEIR SK FUNDS FOR INCENTIVIZING VACCINATION ACTIVITIES IN THEIR RESPECTIVE BARANGAYS SUCH AS PROVISION OF FOOD ITEMS, GOODS, SCHOOL SUPPLIES AND OTHER ESSENTIAL PRODUCTS AND RAFFLE PROMO IN SUPPORT TO EXECUTIVE ORDER NO. 29-2021 OF GOVERNOR FRANCIS JOSEPH G. ESCUDERO

WHEREAS, it is a state policy to protect and promote the right to health of its people and instill health consciousness among them;

WHEREAS, on March 23, 2020, under SP Resolution No. 075 and thru an Executive Order No. 13, Series of 2020 issued by the Hon. City Mayor Ma. Ester E. Hamor, Sorsogon City was declared under a State of Calamity following the sharp increase in the number of confirmed COVID 19 cases throughout the country;

WHEREAS, there is a need to incentivize and ramp-up the conduct of vaccination program in the City of Sorsogon to meet the national target of 70% and to attain herd immunity;

WHEREAS, the City Government of Sorsogon was directed to meet the target by inoculating 15,232 target within 6 weeks;

WHEREAS, Section 8 of the Executive Order No. 29-2021 provides strategies by incentivizing vaccination activities among others (1) provision of food items, goods, school supplies and other essential products and (2) raffle promo;

WHEREAS, Sangguniang Kabataan (SK) of the 64 barangays shall endeavour and maximize its efforts to contribute and support the City Government of Sorsogon to meet the said target in compliance with the said order;

WHEREAS, it is suggested that provisions for food items, good, medical and school supplies be extended to individuals in the barangay aged 12-14 years old and members of the Katipunan ng Kabataan (aged 15-30);

WHEREAS, it is also suggested that SK of 64 barangay shall likewise conduct raffle promos with reference to Bakunado Panalo as per DOH Circular 2021-0415;

WHEREAS, it is likewise suggested that the conduct of raffle promos and provision of foods, goods, school supplies and other essential products be also extended to the general populace qualified to be vaccinated;

WHEREAS, under Section 16 of the Local Government Code, every local government unit, including the barangay, has the implied power to do all things necessary, appropriate, or incidental to govern efficiently and effectively, promote general welfare, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Sangguniang Kabataan (SK) of the 64 barangays are hereby enjoined to implement incentive programs for vaccination activities against COVID 19 to further encourage individuals to be vaccinated;

NOW THEREFORE, on motion of **Hon. Lorenz S. Abenion** duly seconded by **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to request all Sangguniang Kabataan (SK) of the 64 barangays in the City of Sorsogon to utilize portion of their SK Funds for Incentivizing Vaccination Activities in their respective barangays such as provision of food items, goods, school supplies and other essential products and raffle promo in support to Executive Order No. 29-2021 of Governor Francis Joseph G. Escudero

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
