WHEREAS, numerous commuters and residents are now complaining of the dilapidated small bridge in Tagalwoy, Gatbo, Bacon District, Sorsogon City;

WHEREAS, said bridge condition also poses risk to the general riding public and if left unattended may cause road accidents endangering the lives and property of our fellowmen;

WHEREAS, dilapidated bridge is located in the main road catering large volume of public utility vehicles;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution respectfully requesting Engr. Roel D. Domer, OIC – City Engineer to conduct an ocular inspection and structural stability of the small bridge in Tagalwoy, Gatbo, Bacon District, Sorsogon City;
