**RESOLUTION ENACTING AN ORDINANCE OFFICIALLY NAMING THE
EDIFICE IN FRONT OF SORSOGON GOODLUCK COMMERCIAL,
MAGSAYSAY ST. SORSOGON CITY AS PLAZA SQUARE**

WHEREAS, Section 13 (c) (5) of the Local Government Code of 1991 provides that “ the Sanggunians of component cities and municipalities may, in consultation with the Historical Commission, change the name of the following within its territorial jurisdiction.....” (5) Any other public place or building owned by the city/municipal government;

WHEREAS, on August 24, 2021 regular session of the 7th City Council, Hon. Franco Eric O. Ravanilla under other matters proposed to pass an ordinance officially naming the edifice in front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City after the City Government took possession of such on August 1, 2021;

WHEREAS, committee hearings and public consultation were conducted to recollect the usual name of the said edifice prior to introduction of BOT by and between LKY Group of Companies and the former Municipality of Sorsogon;

WHEREAS, this measure is in line with the goal of the Sorsogon Arts Council in redefining and retracing history and memory of Sorsogon by naming the said edifice "PLAZA SQUARE";

WHEREAS, foregoing premises considered and after deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution enacting an ordinance naming the edifice in front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City as Plaza Square;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to enact an ordinance officially naming the edifice in front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City as Plaza Square.

City Ordinance No. 23, Series of 2021

AN ORDINANCE OFFICIALLY NAMING THE EDIFICE IN FRONT OF SORSOGON GOODLUCK COMMERCIAL, MAGSAYSAY ST. SORSOGON CITY AS PLAZA SQUARE

Be it ordained by the 7th City Council in session that:

Section 1 TITLE

This ordinance shall be known as ordinance officially naming the edifice in front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City as PLAZA SQUARE.

Section 2 SCOPE AND LIMITATION

This ordinance shall only be limited to naming the edifice in front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City.

Section 3 OFFICIAL DECLARATION

It is hereby officially declared that the edifice front of Sorsogon Goodluck Commercial, Magsaysay St. Sorsogon City be named as "PLAZA SQUARE"

Section 4 SEPARABILITY CLAUSE

Any part or provisions hereof declared by competent authorities to be invalid or unconstitutional other provisions not affected thereby shall continue to be in full force and effect.

Section 5 REPEALING CLAUSE

All ordinances, resolutions and regulations or any part(s) thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

Section 6 EFFECTIVITY

This ordinance shall take effect upon approval and compliance with the posting requirement in conspicuous places in Sorsogon City.
