RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE RESOLUTION NO. 10, SERIES OF 2021 (RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF FIVE HUNDRED THOUSAND (P500,000,00) PESOS FROM ITEM NO. V-5 (INFRASTRUCTURE DEVELOPMENT-REPAIR OF EXISTING EVACUATION CENTERS IN BASUD, SAN JUAN-BACON AND ABUYOG) TO ITEM NO. IV-1 (ENVIRONMENTAL MANAGEMENT-MANGROVE REFORESTATION) UNDER THE 2020 20% DEVELOPMENT FUND OF THE CITY OF SORSOGON)

WHEREAS, on November 17, 2021 Hon. MA. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption, approval and enactment of RESOLUTION NO. 10, SERIES OF 2021 OF THE CITY DEVELOPMENT COUNCIL (CDC) held last November 15, 2021 entitled "RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF FIVE HUNDRED THOUSAND (P500,000,00) PESOS FROM ITEM NO. V-5 (INFRASTRUCTURE

DEVELOPMENT-REPAIR OF EXISTING EVACUATION CENTERS IN BASUD, SAN JUAN-BACON AND ABUYOG) TO ITEM NO. IV-1 (ENVIRONMENTAL MANAGEMENT- MANGROVE REFORESTATION) UNDER THE 2020 20% DEVELOPMENT FUND OF THE CITY OF SORSOGON)

**WHEREAS,** the identified programs, projects and activities will contribute to the attainment of socio-economic development of the City and more beneficial to the people;

WHEREAS, after thorough deliberation of the projects funded and to be implemented under the 2021 20% Development Fund, the repair of existing evacuation centers in Basud, San Juan, Bacon and Abuyog was not implemented last year and can no longer be implemented this year for the same are being used as quarantine facilities thus the fund will be realigned to purchase additional propagules to cover the losses due to mortality of mangroves relative to the establishment and maintenance of mangrove plantation in the Brgys of Capuy, West District, Salvacion and Sta. Lucia, Bacon District funded under the 2020 20% Development Fund;

**WHEREAS,** the projects identified are consistent with the priorities under the Local Development Plan and complements the overall national and global goals and aspirations;
