WHEREAS, on November 17, 2021 Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption, approval and enactment of RESOLUTION NO. 11, SERIES OF 2021 OF THE CITY DEVELOPMENT COUNCIL (CDC) held last November 15, 2021 entitled “RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF ONE MILLION ((P1,000,000,00) PESOS FROM ITEM NO.
