RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE V, REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, RODEL P. TORNILLA, MABE, RELATIVE TO THE IMPLEMENTATION OF THE PROJECT ENTITLED SWINE BREEDER AND PRODUCTION FARM LIVELIHOOD ASSISTANCE THROUGH ARTIFICIAL INSEMINATION FOR SWINE IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the November 23, 2021 Regular Session of the 7th City Council is a letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated November 15, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Department

of Agriculture – Regional Field Office V, represented by its Regional Executive Director, Rodel P. Tornillo, MABE, relative to the implementation of the project entitled Swine Breeder and Production Farm Livelihood Assistance through artificial insemination for swine in the City of Sorsogon;

WHEREAS, the said project amounting to **Three Million** (Php 3,000,000.00) Pesos shall be established at Bacon District, Sorsogon City under a Special Implementing Unit headed by Veterinary Office thus shall be able to provide income opportunities for local residents and an avenue for agricultural development;

WHEREAS, Republic Act No. 8435 otherwise known as Agriculture and Fisheries Modernization Act of 1997 (AFMA) sets out the government’s policies in the agriculture sector in attaining equitable distribution of opportunities, income, and wealth, expanding productivity and sustaining increase in production of goods and services thereby raising the quality of life of the people;

WHEREAS, pursuant to the DA-Regional Field Office 5 and the LGU jointly pledge to extend full support and cooperation for the successful implementation of the project entitled “Swine Breeder and Production Farm Livelihood Assistance through Artificial Insemination for Swine” under Livestock Enterprise Development Project of the National Livestock Program (NLP);

WHEREAS, attached to the letter is a copy of the draft Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Agriculture – Regional Field Office V, represented by its Regional Executive Director, Rodel P. Tornillo, MABE, relative to the implementation of the project entitled Swine Breeder and Production Farm Livelihood Assistance through artificial insemination for swine in the City of Sorsogon;
