**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY
MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF
AGREEMENT (MOA) WITH THE SORSOGON STATE UNIVERSITY (SSU)
FOR THE USE OF SSU – ENGINEERING CAMPUS AS COVID – 19
VACCINATION SITE LOCATED AT SITIO BARIBAG, BARANGAY
BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

WHEREAS, among the items deliberated during the November 23, 2021 Regular Session of the 7th City Council is a letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated November 16, 2021 with attached copy of the draft Memorandum of Agreement (MOA), addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, Secretary to the SP, respectfully requesting for the passage of a Resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Sorsogon State

University (SSU) for the use of SSU – Engineering Campus as COVID – 19 Vaccination Site located at Sitio Baribag, Barangay Bibincahan, Eastt District, Sorsogon City;

WHEREAS, the City Government of Sorsogon thru its Health Office is currently expediting inoculation activities as part of the local efforts to abate COVID – 19 and reach herd immunity in the City of Sorsogon;

WHEREAS, to ensure its continuous implementation, LGU – Sorsogon City is in need of a venue that is conducive to vaccination activities and Sorsogon State University (SSU) has an existing off-site campus for its engineering course which has a huge hall that is spacious and can accommodate large number of persons to be vaccinated and will serve as vaccination site;

WHEREAS, SSU has acceded to use the said area provided that LGU – Sorsogon City shall be responsible for the upkeep and cleanliness of the said area;

WHEREAS, attached to the letter is a copy of the draft Memorandum of Agreement (MOA) for further perusal of the 7th City Council;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Sorsogon State University (SSU) for the use of SSU – Engineering Campus as COVID – 19 Vaccination Site located at Sitio Baribag, Barangay Bibincahan, East, District, Sorsogon City;
