## Resolution No. 375, Series of 2021

RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PUNONG BARANGAYS OF SIXTY – FOUR (64) BARANGAYS IN THE CITY OF SORSOGON RELATIVE TO THE USE OF RADIO COMMUNICATION EQUIPMENT.

WHEREAS, among the items deliberated during the November 23, 2021 Regular Session of the 7<sup>th</sup> City Council is the inclusion of a letter request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated November 22, 2021 addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E. Domasian, Secretary to the SP respectfully requesting for the passage of a Resolution authorizing her to enter into a Memorandum of Understanding (MOU) with the Punong Barangays of Sixty-Four (64) Barangays in the City of Sorsogon relative to the use of radio communication equipment;

WHEREAS, said equipment shall be provided by the LGU to various barangays in line with the commitment to ensure the safety of human lives by strengthening the early warning system in communities and with this, both shall be able to establish a Community-Based Early Warning System to prevent loss of life and damage to property in time of calamities;

**WHEREAS,** it is the policy of the State to strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

**WHEREAS**, LGU – Sorsogon City in its commitment to ensure safety of human lives, is strengthening the early warning system in the communities to prevent loss of live and reduce material and economic impact of disasters;

**WHEREAS,** LGU – Sorsogon City aims to establish a Community-Based Early Warning System thru the provision of a Base Radio to disseminate timely warnings for effective response in which the Barangay recognizes the value of active community involvement for an effective early warning system;

**WHEREAS**, attached to the letter is a copy of the draft Memorandum of Understanding (MOU) for further perusal of the 7<sup>th</sup> City Council;

**NOW THEREFORE**, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Ma. Teresa D. Perdigon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding (MOU) with the Punong Barangays of Sixty-Four (64) Barangays in the City of Sorsogon relative to the use of radio communication equipment;
