**RESOLUTION INTERPOSING NO OBJECTION ON VARIOUS APPLICATIONS  
FOR THE OPERATIONS OF E-SABONG IN THE TERRITORIAL JURISDICTION  
OF THE CITY OF SORSOGON SUBJECT TO COMPLIANCE OF APPROPRIATE  
DOCUMENTATION AND REQUIREMENTS.**

**WHEREAS**, following the issuance of E-Sabong licenses to several corporations by  
PAGCOR, local interested business enthusiast filed their respective applications before  
the Sangguniang Panlungsod;

**WHEREAS**, among the requirements thereof is the Resolution of No Objection to  
be issued by the Sanggunian concerned;

**WHEREAS**, considering the various applications filed before the Sangguniang  
Panlungsod, the Committee on Games and Amusement made it a point to be cautious  
especially when E-Sabong was just recently introduced;

**WHEREAS**, in one of the committee hearing conducted by the Committee on Games and Amusement, Mr. Rodel Ferreras, OIC, Permits and Licenses Section shared several inputs and information as regards to E-Sabong Requirements after he managed to have a conversation with a legal officer from PAGCOR;

**WHEREAS**, following the information shared before the committee by Mr. Rodel Ferreras, the committee decided to recommend for the following;

1. The passage of a resolution interposing no objection on various application for E-Sabong pending before the Sangguniang Panlungsod provided that applicants shall adhere and comply with requirements imposed upon by PAGCOR and other government entities;
2. That all documents submitted before the legislative department in relation to the herein mentioned E-Sabong applications be submitted to the Office of the City Mayor through the Permits and Licenses Section;

**WHEREAS**, for purposes of this resolution, hereunder are the official list of E-Sabong Applicants as follows;
