RESOLUTION RESPECTFULLY REQUESTING THE HON. EVELINA G. ESCUDERO, REPRESENTATIVE, 1st CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON TO ALLOCATE FUNDS INTENDED FOR THE CONSTRUCTION OF A BRIDGE AT SITIO TAGALWOY, BARANGAY GATBO, SORSOGON CITY

WHEREAS, on November 16, 2021, the 7th City Council passed and approved Resolution No. 359, Series of 2021, requesting the City Engineering Office to conduct an ocular inspection and check the structural stability of the small bridge (Box Culvert-part of national road);

WHEREAS, in response thereto, on November 19, 2021, the City Engineering Office submitted their Inspection Report;

WHEREAS, the City Engineering Office on its findings declared that the subject is unsafe for heavy loaded vehicles that may cause total collapse of the structure and vehicular accidents may occur within the area due to its dilapidated/deflected barrel;

WHEREAS, it also declared therein that major cracks and exposed corroding reinforcements are visible at the bottom barrel, thus, sign of unstable structure;
WHEREAS, with the deflected barrel and major cracks on wing walls, the box culvert will not be able to support a large volume of public utility vehicles;

NOW THEREFORE, on motion of **Hon. Lorenz S. Abenion**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve respectfully request the Hon. Evelina G. Escudero, Representative, 1st Congressional District, Province of Sorsogon to allocate funds intended for the construction of a bridge at Sitio Tagalwoy, Barangay Gatbo, Sorsogon City.
