**A RESOLUTION DESIGNATING NEW ENTRANCE AND EXIT AT THE
SORSOGON CITY PUBLIC MARKET**

WHEREAS, to facilitate the proper flow of transaction at the Sorsogon City Public Market, there is a need to adjust the entrance and exit to/from the public market.

WHEREAS, as deemed necessary by the Executive Department of the City LGU through its dialogue with the marginalized vendors on October 28, 2021, such designation of new entrance and exit to the proposed places is now implemented.

WHEREAS, pending and amendments to the Market Code of 2009 and solving the perennial problem of lack of space at the public market, piecemeal solution of primary significance shall be exercised by the 7th City Council, including the subject matter of this Resolution.

NOW THEREFORE, on motion of **Hon. Joven Francis J. Laura** duly seconded by **Hon. Danilo A. Deladia**, be it resolve to designate the circumferential road leading to Magsaysay Street, Corner East West Bank and the entrance to the Sorsogon City Public

Market leading to the Fruit Section fronting Magsaysay St. as consumer entrance to the Sorsogon City Public Market and the circumferential road leading road going to Rizal Street as consumer exit.

RESOLVED FURTHER, that the entrance of the vehicle shall be at the circumferential road leading to Rizal Street while the exit shall be the circumferential road leading to Magsaysay Street, corner East West Bank.

RESOLVED FINALLY, that copy of this resolution be also furnished to the market administration through the office of MR. CHRISTIAN SANCHEZ, the market supervisor, for purposes of implementation.
