RESOLUTION RESPECTFULLY URGING THE CITY VETERINARY OFFICE TO CONDUCT CHECKPOINT IN THE STRATEGIC AREAS IN SORSOGON CITY TO PREVENT INDISCRIMINATE SELLING OF PORK AND HOGS TO NON-RESIDENTS OF SORSOGON TO PRE-EMPT SUDDEN INCREASE OF PRICES OF MEAT PRODUCTS THIS HOLIDAY SEASON

WHEREAS, the City Government of Sorsogon desires that this coming holiday season and while we are opening our local economy gradually to everyone we adhere to the policies of preventing our constituents from experiencing sudden increase of prices of meat products due to limited supply in our local market;

WHEREAS, the shortage of meat products during holiday season usually happens because traders from other parts of the region come to buy and sell the same in Metro Manila:

WHEREAS, evidently if this situation continues, there will be shortage of supply meat products in our local market which would lead to increase in prices;

**NOW THEREFORE**, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Franco Eric O. Ravanilla**, be it resolve to respectfully urge the City Veterinary Office to conduct checkpoint in the strategic areas in Sorsogon City to prevent indiscriminate selling of pork and hogs to Non-Residents of Sorsogon to pre-empt sudden increase of prices of Meat Products this Holiday Season.

**RESOLVED FINALLY**, that it is deemed prayed that the City Veterinary Office should also activate the City Task Force Hot Meat for this purpose and appropriate measures to regulate this incidence.
