**RESOLUTION RESPECTFULLY REQUESTING ATTY. MARTIN B. DELGRA, III, CHAIRMAN, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) TO EXTEND THE CONSOLIDATION OF PUBLIC UTILITY JEEPNEYS PUJ'S) IN THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP).**

**WHEREAS**, the Department of Transportation (DOTr) initiated the Public Utility Vehicle Modernization Program (PUVMP) in 2017 to make the country's public transportation system more efficient and environmentally sustainable;

**WHEREAS**, also stated hereof is that the program's environmental and economic benefits would be equally shared by the commuters, operators and drivers because of the decreased traffic congestion and emissions, a higher monthly wages and incentives for drivers, and better health for both commuters and drivers;

**WHEREAS**, following the onset of pandemic, some public utility jeepney transport groups failed to comply and act in accordance with the guidelines set forth by the Land

Transportation Franchising Regulatory Board (LTFRB) specially on matters pertaining to consolidation of public utility jeepneys (PUJs) as required by the said office;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution respectfully requesting Atty. Martin B. Delgra, III, Chairman, Land Transportation Franchising Regulatory Board (LTFRB) to extend the consolidation of Public Utility Jeepneys PUJ's) in the Public Utility Vehicle Modernization Program (PUVMP);

**NOW THEREFORE**, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Nestor J. Baldon**, resolve as it is hereby resolved to respectfully request Atty. Martin B. Delgra, III, Chairman, Land Transportation Franchising Regulatory Board (LTFRB) to extend the consolidation of Public Utility Jeepneys PUJ's) in the Public Utility Vehicle Modernization Program (PUVMP);
