**RESOLUTION AUTHORIZING THE CHANGE OR TRANSFER OF THE
ENCLOSURE (CONSTRUCTION OF PERIMETER FENCE AT THE NURSERY-
BARANGAY BIBINCAHAN) OF THE AREA FROM ONE SIDE TO THE OTHER
SIDE OF THE LOT COVERING THEREIN, AS PER RECOMMENDATION OF
THE CITY ENGINEERING OFFICE**

WHEREAS, on November 22, 2021, City Engineering Office forwarded to the Sangguniang Panlungsod copy of its inspection report on the project for the construction of perimeter fence at the nursery located at SPPVS, Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, in its ocular site inspection held on June 7, 2021, the inspection team were hindered/halted by the residents currently occupying the area and thereby requested for consideration such as the provision of a temporary or permanent relocation prior to the implementation of the project;

WHEREAS, the said individuals were already identified as candidate beneficiaries of the onsite relocation of the Urban Poor Affairs under the “Taas Noo, Ciudadano Ako Program” one of the components of the 10 Point Agenda (plus one) of the present administration;

WHEREAS, the program however was suspended due to a private claimed issue and the onsite relocation process will resume after the issue has been finally resolved with finality;

WHEREAS, upon consideration of the foregoing premises, the City Engineering Office recommended for the change or transfer of the enclosure (construction of perimeter fence at the Nursery- Barangay Bibincahan) of the area from one side to the other side of the lot covering therein;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by, **Hon. Danilo A. Deladia** resolved as it hereby resolves to authorize the change or transfer of the enclosure (construction of perimeter fence at the Nursery- Barangay Bibincahan) of the area from one side to the other side of the lot covering therein, as per recommendation of the City Engineering Office.
