RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH MR. MARVIN KENNETH S. BAILON, HEAD, BUSINESS DEVELOPMENT/MARKET PLANNING AND CONTRACTS, BACON MANITO GEOTHERMAL, INC. (BGI, INC.) RELATIVE TO SEVENTY (70) SCHOLARSHIP SLOTS FOR OUTSTANDING STUDENTS FROM SIXTY FOUR (64) BARANGAYS OF THE CITY OF SORSOGON AS PART OF LATTER'S CORPORATE SOCIAL RESPONSIBILITY (CSR).

WHEREAS, Sorsogon City is blessed with geothermal energy source wherein Bacon-Manito Geothermal, Inc. is the major player generating geothermal energy supporting several distribution utilities in the entire Island of Luzon;

WHEREAS, the aforementioned scholarship slots is a long time overdue corporate social responsibility after decades of existence of Bacon Manito Geothermal, Inc.;

WHEREAS, such scholarship slots would at the very least compensate the ecological impact of geothermal operations especially in the neighboring barangays;

WHEREAS, for purposes of this resolution, the seventy scholarship shall come from sixty four barangays and the remaining six scholarship slots shall be equally prorated for huge barangays in the city;

WHEREAS, foregoing premise considered and after due deliberations on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding with Mr. Marvin Kenneth S. Bailon, Head, Business Development/Market Planning and Contracts, Bacon Manito Geothermal, Inc.
