DONATION COVERING A PORTION OF A PARCEL OF LAND DESIGNATED
AS LOT 8 CONSISTING AN AREA OF FIVE HUNDRED (500) SQUARE
METERS SITUATED AT THE CITY HALL COMPOUND, DIVERSION ROAD,
CABID-AN, EAST DISTRICT, SORSOGON CITY IN FAVOR OF THE
PHILIPPINE RED CROSS (PRC)- SORSOGON CHAPTER REPRESENTED BY
ATTY. ARNULFO L. PERETE, CHAIRMAN OF THE BOARD OF DIRECTORS**

WHEREAS, on December 7, 2021, the 7th Regular Session of the City Council, the
august body discussed the letter request of the Local Chief Executive respectfully
requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City
Mayor, Sorsogon City to enter into a Deed of Conditional Donation covering a portion of
a parcel of land designated as lot 8 consisting an area of Five Hundred (500) square meters
situated at the City Hall Compound, Diversion Road, Cabid-an, East District, Sorsogon City

in favor of the Philippine Red Cross (PRC) Sorsogon Chapter represented by Atty. Arnulfo L. Perete, Chairman of the Board of Directors;

WHEREAS, said donation shall pave the way for the establishment of an edifice of an edifice for the Philippine Red Cross (PRC) where they can perform their functions in line with the delivery of humanitarian services in favor of the people of Sorsogon;

WHEREAS, stipulated in the Deed are the obligations of the donor and done as well as the agreement that any deviation from the conditions therein shall cause the automatic revocation of the donation;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E.
