RESOLUTION ISSUING TRICYCLE FRANCHISE TO SIX (6) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 367, SERIES OF 2021 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

WHEREAS, SP Resolution No. 367, Series of 2021, approved on November 23, 2021 officially cancelled and revoked tricycle franchises in favor of the city government of Sorsogon, in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020";

WHEREAS, on December 1, 2021, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the six (6) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **EMMANUEL HERRERA** of Barangay Pangpang, West District, Sorsogon City for Tricycle Franchise No. 4561/PVTAS.

2. **RONNEL D. DIO** of Barangay San Jose, Bacon District, Sorsogon City for Tricycle Franchise No. 3020/BPCBSTODA.

3. **QUENNIE D. SANCHEZ** of Barangay Balete, Bacon District, Sorsogon City for Tricycle Franchise No. 0545/PTODA.

4. **SERGIO D. DELADIA, JR.** of Barangay San Pascual, Bacon District, Sorsogon City for Tricycle Franchise No. 3127/SSBCCTODA.

5. **FRANCISCO T. LEONCITO** of Barangay Rizal, West District, Sorsogon City for Tricycle Franchise No. 2087/CAMTUTODA.

6. **EVANGELINE L. TWIFORD** of Barangay Sampaloc, East District, Sorsogon City for Tricycle Franchise No. 0602/PTODA.

WHEREAS, Section 14 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides that the Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to issue tricycle franchise to six (6) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP Resolution No. 367, Series of 2021 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
