MERALPES, CITY ACCOUNTANT AS MAKER/USER, IN THE INTENT OF THE CITY GOVERNMENT TO APPLY FOR "weaccess" WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), TO FACILITATE FAST AND ELECTRONIC ACCESS ON ALL TRANSACTIONS MADE BY THE CITY TREASURER'S OFFICE (CTO) WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) AS DEPOSITORY BANK.

WHEREAS, among the items deliberated during the December 07, 2021 Regular Session of the 7th City Council is a letter-request from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated December 03, 2021 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan E.
