RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY AS AUTHORIZER, MS. MAGDALENA D. PALADIN, CITY TREASURER AS MAKER/USER AND MS. CHRISTINE N. MERALPES, CITY ACCOUNTANT AS MAKER/USER, IN THE INTENT OF THE CITY GOVERNMENT TO APPLY FOR "weaccess" WITH THE LAND BANK OF THE PHILIPPINES (LBP), TO FACILITATE FAST AND ELECTRONIC ACCESS ON ALL TRANSACTIONS MADE BY THE CITY TREASURER'S OFFICE (CTO) WITH THE LAND BANK OF THE PHILIPPINES (LBP) AS DEPOSITORY BANK.

WHEREAS, among the items deliberated during the December 07, 2021 Regular Session of the 7th City Council is a letter-request from Ms. Magdalena D. Paladin, Acting City Treasurer, City Treasurer's Office (CTO) dated March 05, 2021 addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, respectfully requesting for the passage of a Resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City as Authorizer, Ms. Magdalena D. Paladin, City Treasurer as Maker/User and Ms. Christine N. Meralpes, City Accountant as Maker/User, in the intent of the City Government to apply for "weAccess" with the Land Bank of the Philippines (LBP), to facilitate fast and electronic access on all transactions made by the City Treasurer's Office (CTO) with the Land Bank of the Philippines (LBP) as depository bank;
