RESOLUTION APPROVING THE ONE (1) APPLICATION FOR CANCELLATION OF TRICYCLE FRANCHISE AND THEREBY AUTHORIZING QUALIFIED WAITING APPLICANTS TO SUBSTITUTE OR REPLACE THE FORMER HOLDER THEREOF TO OPERATE TRICYCLE-FOR-HIRE IN THE CITY OF SORSOGON UNDER THE SAME FRANCHISE, MOTORCYCLE UNIT AND ROUTE OF OPERATION AS ALLOWED UNDER SECTION 13 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

WHEREAS, the following was applied for dropping/cancellation of Tricycle Franchise due to the demise of the holder thereof with the Death Certificate attached and made integral part hereof, to wit:

1. **BEATRIZ S. BELNAS** of Barangay San Juan, East District, Sorsogon City, died on August 28, 2016 a grantee of a Tricycle Franchise No. 1449/Tricycle Franchise Plate No. 1449 for Tricycle-for-Hire Service with the route covered by SJEDTODA, valid up to July 26, 2024 and with the following technical description, to wit:

WHEREAS, Section 13 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides:

SECTION

VALIDITY OF FRANCHISE

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

WHEREAS, FREDDIESANTOS S. BELNAS, resident of Barangay San Juan, East District, Sorsogon City, applied to substitute or replace the former owner hereof in conformity with the provisions here above stated;

WHEREAS, the 7th City Council finds the herein application to be meritorious and the applicant is qualified to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to approve the one (1) application for cancellation of tricycle franchise and thereby authorizing priority applicant to substitute or replace the former holder thereof to operate Tricycle-for-Hire in the city of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise code of 2020".
