RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO GRANT OVERTIME PAY TO ALL MEDICAL HEALTH WORKERS, DRIVERS, UTILITY WORKERS AND OTHER PERSONNEL WHETHER PERMANENT, CONTACTUAL OR JOB ORDER IN NATURE WORKING BEYOND PRESCRIBED WORKING HOURS, AT THE VACCINATION FACILITIES RENDERING SERVICES FOR RESBAKUNA AND NATIONAL VACCINATION ACTIVITIES.

WHEREAS, DBM Budget Circular No. 10 Series of 1996 prescribe the guidelines and procedures on the rendition of overtime services with pay of Government Personnel.

WHEREAS, abovementioned budget circular covers all incumbents of positions of chief of division and below under permanent, temporary or casual status, and contractual personnel whose employment is in the nature of a regular employee.

WHEREAS, Simultaneous vaccination were being held in Sorsogon City to meet Herd immunity and protection of all residents against Covid 19 Virus and other Variant.

WHEREAS, National Vaccination Day were also launched by the Department of Health and National Government Agencies from November 29 – December 01, 2021 aiming to vaccinate 15 million Filipinos.

WHEREAS, Medical Health Workers, Drivers, Utility Workers, and other personnel whether permanent, contractual, or Job order in nature were working hard beyond prescribed working hours at the vaccination facilities rendering services for Resbakuna and National Vaccination Activities.

WHEREAS, Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental, for its efficient and effective governance and those which are essential for the promotion of the general welfare.

NOW THEREFORE, on motion of **Hon. Mary Ellen D. Jamisola**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to Grant Overtime Pay to All Medical Health Workers, Drivers, Utility Workers And Other Personnel Whether Permanent, Contactual Or Job Order In Nature Working Beyond Prescribed Working Hours, at the Vaccination Facilities Rendering Services for Resbakuna and National Vaccination Activities.
