RESOLUTION APPROVING THE OFFICIAL CANCELLATION/REVOCATION OF FOUR (4) TRICYCLE FRANCHISES AS HEREUNDER IDENTIFIED FOR VIOLATION OF SECTION 20 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE “SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020”

WHEREAS, the following Tricycle Franchises are hereby officially cancelled and revoked in favor of the city government of Sorsogon for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”, to wit:

1. **Tricycle Franchise No. 3398/Tricycle Franchise Plate No. 3398** awarded in the name of **NORMA JANE A. JAO** of Barangay Bibincahan, East District, Sorsogon City, with the route covered by PTODA and with the following motorcycle technical description, to wit:

WHEREAS, the 7th City Council, through its Committee on Franchise and the City Tricycle Franchising Regulatory Office, finds the aforesaid Tricycle Franchise holder is in violation Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”;
