RESOLUTION APPROVING THE OFFICIAL CANCELLATION/REVOCATION OF THREE (3) TRICYCLE FRANCHISES AS HEREUNDER IDENTIFIED FOR VIOLATION OF SECTION 20 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

**WHEREAS**, the following Tricycle Franchises are hereby officially cancelled and revoked in favor of the city government of Sorsogon for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020", to wit:

**WHEREAS,** Section 20 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides:

## SECTION 20 GROUNDS FOR CANCELLATION AND REVOCATION OF FRANCHISE

The following are grounds for the cancellation and revocation of Tricycle Franchise:

- 1. Violation of any provision herein and of the terms and conditions in the franchise;
- 2. Violation of related laws and ordinances;
- 3. Any motor vehicle involved in the commission of crimes other than those defined by the Revised Penal Code (RPC) as reckless imprudence shall be a cause for an automatic revocation of franchise and be permanently banned from being a franchise holder, unless the franchise grantee can submit the lower court's findings of non-culpability;
- 4. Any motor vehicle who is involved in vehicular accidents or those defined by the RPC as crimes due to reckless imprudence shall undergo a process of revocation if it cannot present certificate of settlement issued by PNP or MTC/RTC Clearance as the case may be;
- 5. Tricycle is not registered with LTO;
- 6. Nonpayment of regulatory fees;
- 7. Expired franchises not renewed in the reglamentary period;
- 8. Non-application for MTOP within one (1) year.

**WHEREAS**, the 7<sup>th</sup> City Council, through its Committee on Franchise and the City Tricycle Franchising Regulatory Office, finds the aforesaid Tricycle Franchise holder is in violation Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020";

**NOW THEREFORE,** on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to approve the official cancellation/revocation of three (3) Tricycle Franchises as hereunder identified for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
