**RESOLUTION APPROVING THE REQUEST FOR ACCREDITATION OF ABANGAN

WHEREAS, among the items deliberated during the December 14, 2021 Regular Session of the 7th City Council is a letter-request from Mr. Bienvenido D. Chavez, President, Abangan San Pascual Farmers Association dated December 10, 2021 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, regarding the request for accreditation of Abangan San Pascual Farmers Association by the City Council;

WHEREAS, Abangan San Pascual Farmers Association has applied for accreditation at the Sangguniang Panlungsod Sorsogon City pursuant to Memorandum Circular No. 2007-89 dated February 1, 2011 of the Department of the Interior and Local Government (DILG);

WHEREAS, the criteria for accreditation as embodied in the Memorandum Circular No. 2007-89 of the DILG was substantially complied by the association;

WHEREAS, after careful scrutiny of the documents submitted by the applicant, the Committee on Livelihood, Cooperatives, PO's, GO's and NGO's found it sufficient and thus recommends for its approval;

WHEREAS, it is the duty of the Local Government Unit to develop the potentials and capabilities of people by providing support on their venture towards enhancing their economic and social well-being;


