RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE NATIONAL MAPPING AND RESOURCE INFORMATION AUTHORITY (NAMRIA), REPRESENTED BY ITS ADMINISTRATOR, USEC. PETER N. TIANGCO, PhD, RELATIVE TO THE PROVISION OF A NINE LARGE SCALE @ 1:10,000 TOPOGRAPHIC BASE MAP IN SHAPE FILE FORMAT COVERING THE CITY OF SORSOGON.

WHEREAS, on November 15, 2021 the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing the local chief executive to enter into a Memorandum of Understanding (MOU) with the National Mapping and Resource Information Authority (NAMRIA), represented by its

Administrator Usec. Peter N. Tiangco, PhD, relative to the production of the Topographic Base Map in Shape File Format Covering the City of Sorsogon;

WHEREAS, products shall be provided by the NAMRIA to the City Government **free of charge** and shall be among the documents included for the Comprehensive Land Use Plan of the LGU;

WHEREAS, NAMRIA, as the central mapping agency of the national government, is the repository of digital base maps, aerial photographs, remotely sensed data and other related geographic information, and possesses the expertise in map making, geographic and resource information services;

WHEREAS, recognizing the need of LGU, NAMRIA is willing to provide such products and intends to protect its interest by preventing the unauthorized use, proliferation, reproduction and sale of its products;

WHEREAS, attached to the letter is a copy of the draft Memorandum of Understanding (MOU) for further perusal of the 7th City Council;

NOW THEREFORE, on motion of the **Hon. Nestor J. Baldon**, duly seconded by the **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding (MOU) with the National Mapping and Resource Information Authority (NAMRIA), represented by its Administrator Usec. Peter N. Tiangco, PhD, relative to the production of the Topographic Base Map in Shape File Format Covering the City of Sorsogon;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance;


RESOLVED FINALLY that copies of the Memorandum of Understanding (MOU) entered into by the parties herein mentioned shall be an integral part of this resolution and the same be furnished to the Secretary of the Sangguniang Panlungsod for records and archives purposes.
