**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A CONTRACT RELATIVE TO THE EMERGENCY PURCHASE OF THE NEEDS OF THE CITY HEALTH OFFICE (CHO) FOR COVID ASSISTANCE USING THE FUNDS DOWNLOADED FROM ODESFA AMOUNTING TO THREE MILLION PESOS (PHP 3,000,000.00).**

**WHEREAS**, among the items deliberated during the December 14, 2021 Regular Session of the 7<sup>th</sup> City Council is a letter-request from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, dated December 03, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, SP Secretary, respectfully requesting for the passage of a resolution authorizing her to enter into a Contract relative to the emergency purchase of the needs of the City Health Office (CHO) for covid assistance using the funds downloaded from ODESFA amounting to Three Million Pesos (Php 3,000,000.00);

**WHEREAS**, said amount is part of the Five Million Peso assistance from ODESFA as stipulated in the Memorandum of Agreement (MOA) entered into by the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City with the Office of the President represented by its Executive Secretary, Salvador C. Medialdea;

**WHEREAS**, on April 27, 2021, Resolution No. 133, Series of 2021 had been approved by the 7<sup>th</sup> City Council relative to the grant of Five Million Pesos (Php 5,000,000.00) as financial assistance from the Office of the President, His Excellency, Rodrigo Roa Duterte, in light with the continuing battle of the City Government of Sorsogon against COVID 19 pandemic;

**WHEREAS**, the grant shall be utilized in accordance with pertinent and existing laws, guidelines and regulations issued by the Commission on Audit (COA) to provide food, medicines and other basic necessities of the people affected by the COVID 19;

**WHEREAS**, LGU – Sorsogon City shall be able to expeditiously complete the procurement process thereby ensuring the unhampered delivery of services to the people of Sorsogon City;

**NOW THEREFORE**, on motion of the **Hon. Franco Eric O. Ravanilla**, duly seconded by the **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Contract relative to the emergency purchase of the needs of the City Health Office (CHO) for covid assistance using the funds downloaded from ODESFA amounting to Three Million Pesos (Php 3,000,000.00) ;
